	Payroll – Trustee Berg made a motion to set the hourly pay scale for township employees in 2023 as follows: road superintendent - \$ 25.00 NEW > OLD: \$18.75 road workers (part time) \$ 18.00 NEW > OLD: \$16.00 police chief - \$25.00 NEW > OLD: \$16.00 police officers - \$20.00 NEW > OLD: \$16.00 police officers - \$20.00 NEW > OLD: \$16.00 police officers - \$20.00 NEW > OLD: \$16.00 police officer & drug task force - \$21.00 > NEW > OLD: \$16.00 Zoning officer - \$ 825.00 NEW > OLD: \$725.00 Zoning board members - \$30.00 per hour (minimum pay is one hour) Seasonal or Administrative Help - \$15.00/hr. NEW > OLD: \$12.00 Trustee Lewis seconded the motion to set the hourly pay scale per the above changes for township employees. All answered "Aye" and motion was passed 3-0.	
	Trustee Faulder: To all employees / public as well. We have been underpaying due to the constraints of our budgets. So, these raises are bringing us up to competitive wages. That does not mean everyone gets a large raise every year. In fact, when the next raise comes up it may be only .50 cents. As Trustees, we want to pay competitive wages and keep our employees but we can't raise salaries to an amount that would put them out of a job as their budgets can't support them. Then the employee would have to make a decision. We're happy to support the competitive wages, however, there won't be any more increases like this again. It was really done because our employees deserve the raises to be as competitive as the surrounding areas. They all work equally hard at their jobs so it is the right thing to do but future raises will not be like one.
